#### FROM THE CHAIR OF DEAFNESS FORUM OF AUSTRALIA

3.5 million Australians are currently living with hearing issues, growing to an estimated 7.8 million by 2060, with a current estimated economic impact of \$33.3b in costs to the health and disability systems, and in lost taxes.

Five percent of people who are deaf or hearing impaired will be eligible to enter the National Disability Insurance Scheme.

Hearing health needs an integrated national plan to provide the high-level policy platform for addressing the personal and social costs of hearing health in this country.

We must all work towards creation of a National Action Plan for governments, business and the community.

The year commenced with the introduction of the Roadmap for Hearing Health for Australia by the then Minister Ken Wyatt AM MP involving 11 sector leaders including Deafness Forum of Australia. It involved several months of committee meetings and working groups throughout the Deafness Sector.

Once the Roadmap was finalised (https://www.deafnessforum.org.au/news-and-issues/roadmap-for-hearing-health/) it was important to encourage governments to implement what they could of the 140 recommendations that would improve hearing health services in Australia. A Hearing Health Sector Alliance was formed (www.hearinghealthsectoralliance.org.au) with Deafness Forum being a founding member. This alliance is the next step forward to working towards a *whole of Australia* approach to address hearing health awareness, prevention, industry improvements, and support for marginal groups including Aboriginal and Torres Strait Islanders. None of this would have been possible without the support of all our member organisations and friends across the deafness sector.

Deafness Forum of Australia's work did not stop there. We continued to build strategic relationships with Federal and State Parliamentarians. Two long term milestones were achieved in the past year – the establishment of the first Parliamentary Friends of Hearing Health and Deafness groups in both the NSW and Federal Parliaments. Already, it is paying dividends: it enabled our member organisations to reach out to NSW Parliamentarians to alert the Premier of NSW and Emergency Services Minister to the need for Auslan interpreters to be part of public emergency announcements on TV and the internet. I was excited to learn that our members in other states are planning to create their own Parliamentary Friends' groups.

The National Disability Insurance Scheme is 4 years old and Deafness Forum has been working behind the scenes with the NDIA on gathering vital community wide information to inform the hearing pathway. Like any new social impact scheme, there is always room for improvement, and we were proactive to utilise our networks and authority to bring the right information to the decision-makers in the Agency. In March-June we hosted a series of community and provider forums, then complied a high-level report that shared the new knowledge with the NDIA. I would like to acknowledge the tremendous effort and expertise provided by our adviser Margaret Dewberry and the support of Leonie Jackson in this project.

We continue to work with Australian Federation of Disability Organisations (AFDO) and other Disability sector organisations across all issues involving disability in Australia. We are very ably represented on the board of AFDO by the chair of Hearing Matter Australia, Christine Hunter. The NDIS impacts 500,000 Australians when it is fully rolls out, however there are 5 million declared Australians with a disability plus their families and communities who relies on us to keep the Government informed, and to encourage them to support and improve the National Disability Strategy so we can achieve real diversity and inclusion across our nation.

Our program to enhance hearing care in aged care settings provides learning resources for volunteers, or students and teaching staff in the Diploma of Nursing HLT54115, Certificate III in Individual Support CHC33015 and in Cert IV in Ageing Support CHC43015 and also for CPD purposes. Our program was recently accredited by Audiology Australia and the College of Audiology. This work is crucial - over 70% of Australians aged over 70 have some hearing loss, increasing to around 85% in residential aged care. However, staff of age care service providers and in hospitals are seldom adequately trained to assist those with hearing loss. I am pleased to acknowledge Deafness Forum's volunteers Basil Turner and Emma Scanlan for making this program real.

The future of the National Relay Service has been a cause of community concern. A new contract to manage the Service was awarded and the funding limit has been capped well below the actual cost of running the Service in recent years. Members will be aware that in recent months we have been working to find a way to preserve the CapTel service (https://www.deafnessforum.org.au/captel-inspotlight-at-senate-estimates-hearing/).

Our Libby Harricks Memorial Oration committee saw a changing of the Chair this year with Prof Christopher Lind stepping down after 4 years of steering the committee to be replaced by Prof Catherine McMahon. This year's Orator was from London, Professor Andrew Smith who spoke at the Macquarie University Indigenous hearing health symposium. As always, the Oration brings real hearing health and deafness issues to the agenda based on evidence and experience.

In making this report I am conscious of the danger of overlooking important other contributors. For this I apologise.

During the year we participated in many varied groups and projects that we believed contributed to our work on behalf of our constituents.
